Tauscher Act to Maintain Limits on Russian Nuclear Forces (S. 2394). As your bill importantly notes, if the New START Treaty is not extended or replaced before it expires in 2021, the United States runs the risk of having no legally binding, verifiable limits on Russia's strategic nuclear arsenal for the first time since 1972.

The bipartisan nature of your initiative is important. Historically, nuclear disarmament as a security and moral concern has been supported by leaders of both major political parties. President Ronald Reagan famously argued in his 1984 State of the Union Address: "A nuclear war cannot be won and must never be fought. The only value in our two nations possessing nuclear weapons is to make sure they will never be used. But then would it not be better to do away with them entirely?" President Barack Obama reiterated this conviction in his Prague speech of 2011: "So today, I state clearly and with conviction America's commitment to seek the peace and security of a world without nuclear weapons. I'm not naive. This goal will not be reached quickly — perhaps not in my lifetime. It will take patience and persistence."
